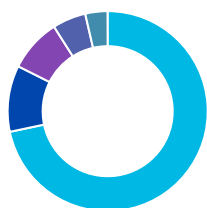

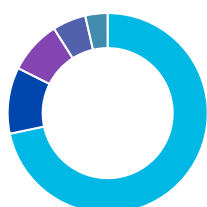
## Region breakdown
