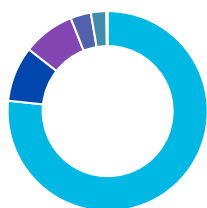

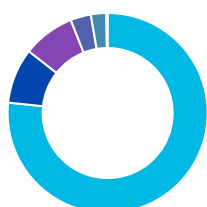
Region breakdown

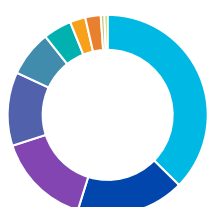
